

#### Rolling Back Clauses in Commercial Item Contracts Imposed Since the Federal Acquisition Streamlining Act of 1994

In 1994, Congress passed the Federal Acquisition Streamlining Act ("FASA"), requiring that federal agencies, to the maximum extent practicable, procure commercial products and services to meet their needs. Federal Acquisition Streamlining Act of 1994, Pub. L. No. 103-355, § 8104, 108 Stat. 3243 (1994) (codified as amended in 41 U.S.C. § 3307 and 10 U.S.C. § 3453). Intending to mirror commercial transactions "to the maximum extent practicable," and keep these procurements as streamlined as possible, FASA also requires that commercial item contracts¹ "include[] only those clauses-- (1) Required to implement provisions of law or executive orders applicable to the acquisition of commercial products or services; or (2) Determined to be consistent with customary commercial practice." 41 U.S.C. § 3307(e)(2)(B); see also FAR 12.301(a).

Despite these express statutory and regulatory requirements, the number of FAR clauses that can or are required to be included in commercial item contracts has drastically increased since FASA's enactment. In 1995, approximately one year after FASA was enacted, there were 28 such clauses. Of the 28 clauses listed in 1995, six were required in every commercial item contract and the remaining 22 were to be included if the contracting officer determined that those clauses were applicable to the particular contract in question. Currently, the FAR lists 99 clauses for commercial item contracts. Of those 99 clauses, 26 are required in every commercial item contract, and the contracting officer is required to include any clauses from the remaining 73 that are applicable to the particular contract in question. The FAR commercial item clauses as of 1995 and January 2025 are listed in Appendix A.<sup>2</sup>

Similarly, there has been a significant increase in FAR clauses that must be flowed down to subcontracts for commercial products or commercial services. In 1995, there were only four such flow down clauses. Today, there are 27. The flow down clauses required as of 1995 and January 2025 are listed in Appendix B.<sup>3</sup>

Here, the term "commercial items" includes both commercial products and commercial services, as those terms are defined in the FAR.

In the appendices below, the clauses added since the enactment of FASA are indicated with yellow highlighting. The clauses with asterisks have been amended since they were promulgated, and the clauses with strikethroughs have been removed or renamed and are no longer applicable.

The number of Defense Federal Acquisition Regulations ("DFARS") provisions that can be included in a commercial item contract has also increased. In 1996, the first year that the DFARS included Part 212 relating to the acquisition of commercial items, there were three such clauses. Now,

The 809 Panel previously identified the ever-increasing list of FAR and DFARS provisions applicable to commercial item contracts as an issue. Specifically, the Panel found that despite FASA's statutory, and corresponding regulatory, language requiring otherwise, the burden on commercial item contractors has continued to increase significantly over time, thereby defeating the FASA's intent. <sup>4</sup> The Panel recommended that the framework for adding provisions that are applicable to commercial item contracts be further narrowed by only allowing clauses to be added if the new provision specifically refers to 41 U.S.C. § 1906, and that the FAR Council should not be left to interpret Congress' silence in making its own determination of whether a provision's inclusion is in the best interest of the Federal Government. The Panel further recommended that 109 clauses (54 FAR and 55 DFARS) included on the lists of clauses applicable to commercial item contracts be removed from those lists. Id. (attached). However, more than six years after the Panel issued its recommendations, only modest changes have been made, such as the promulgation of DFARS 252.244-7000, which has more strictly limited the clauses a prime contractor may flow down to a subcontractor. Setting that development aside, the civilian and defense federal acquisition regulations still permit, if not require, the inclusion of dozens of contract and subcontract clauses in violation of the spirit and express language of FASA.

there are 110. The DFARS commercial item clauses required in 1996 and as of January 2025 are listed in Appendix C.

In this regard, FASA allowed for the addition of later-enacted provisions as requirements for commercial item contracts if: (1) the FAR Council made "a written determination that it would not be in the best interest of the Federal Government to exempt contracts for the procurement of commercial items from the applicability of the provision"; (2) the new provision establishes "criminal or civil penalties"; or (3) the new provision specifically refers to 41 U.S.C. § 1906 and provides that, notwithstanding that section, the provision "shall be applicable to contractors for the procurement of commercial items." Federal Acquisition Streamlining Act § 8003.
